### FIRST PLACE

### SECOND PLACE

Print the photographer's name, address, phone number, and where the photo was taken on the back of each photo or slide mount. Finalists may be asked to submit original materials for publication; these originals will be returned. Photographers retain all rights to their photographs. Alaska Airlines/Horizon Air magazines reserve one-time rights to publication of winning photos, as well as rights to reprint and use photos on the Websites of Paradigm Communications Group and/or Alaska Air Group for promotional purposes.
